At a regular meeting of the Town Board of the Town of Orleans, held at the Town Offices located at 20558 Sunrise Avenue, LaFargeville, New York, on June 12 2019, there were:

**WHEREAS**, by Order of this Board dated May 20, 2019, a public hearing was scheduled to consider the creation of the Town of Orleans Collins Landing Sewer District, pursuant to a certain Map, Plan and Report filed with the Town Clerk; and

**WHEREAS**, the Order scheduling the public hearing was duly posted and published as required by law, and on June 12, 2019 at 7:00 p.m. a public hearing was held to consider all persons interested in the creation of the Town of Orleans Collins Landing Sewer District, and

**WHEREAS**, The Town Board learned during the public hearing that support for the Sewer District exists, and

**WHEREAS**, the Town Board of the Town of Orleans has agreed to create the District, and has asked the Engineer to ensure the Official Map, Plan, and Report reflect the same.

**NOW THEREFORE**, on motion duly made and seconded, this Board made the following determinations, and it is hereby Resolved:

1. The original notice of public hearing was duly published and posted as required by law, and is otherwise sufficient.
2. The Sewer District shall be created to include all parcels identified therein.
3. All property and property owners to be benefited by the proposed District are included within the limits of the proposed District.
4. All of the property owners and all of the property located within the proposed District are benefited thereby.
5. The formation of the Town of Orleans Collins Landing Sewer District pursuant to the Map, Plan and Report is/are on file in the office of the Town Clerk, and upon which the public hearing was held on June 12, 2019 and is in the public interest.
6. The creation of the boundaries of the Sewer District to include the parcels as described in the Map, Plan, Report and providing for the service as described therein is hereby approved.
7. This Resolution is adopted as required by NY Town Law §209-e and is subject to a permissive Referendum.

The foregoing Resolution was offered by Board Member Peter Wilson and seconded by Board Member Mary Ford-Waterman upon a roll call vote of the Board was duly adopted as follows:
